# 4. PUBLIC HEARING ON THE FIRST 5 CALIFORNIA ANNUAL REPORT

# 5. PUBLIC HEARING ON THE REVISION OF THE FIRST 5 SAN BENITO 2018-2025 STRATEGIC PLAN PURSUANT TO HEALTH AND SAFETY CODE SECTION 130140(a)(1)(D)(E) and (F)

Sarah Beatie opens the discussion by noting that the existing F5SB strategic plan is still in effect until the end of 2025, and the plan is to update it when the new Executive Director takes their place to do so. At this time, the Commission is only reviewing the plan and making minor revisions to the list of Commissioners and Staff as they were outdated. The list of both groups has been updated to reflect current members and is pending approval. The Commission and Staff both acknowledge that the goals within the strategic plan are still in effect and First 5 San Benito continues to measure its outcomes.

# 7. REVIEW OF THE DRAFT FY24-25 GASB 74/75 ROLL-FORWARD VALUATION REPORT

Carly Offermann opens the discussion by noting that this GASB report is a requirement for the yearly audit. She describes that the report is a roll-forward, meaning they utilize census information from the previous year and that this was a finding on the previous year's audit. While the report was fixed within the audit cycle and the finding was noted to be resolved, Carly emphasizes that the report satisfies that requirement and has since been corrected to ensure proper reporting going forward. Carly is looking to have an approval of the report pending no material changes to ensure that it can be finalized and ready for the upcoming audit.

Margie Barrios makes a <u>MOTION</u> to approve the FY 24-25 GASB 74/75 Roll forward valuation Report to be finalized with no material changes and submitted for the FY 24-25 Audit.
